### **Executive Reports**

Chairperson (John D. 6/2023): I attended Region this past Saturday 10, 2024. 9 addicts attended. Here is a brief synopsis of what was discussed:

Scheduling the next Writing Steps for Recovery (WSR) meeting

● WSR Chair wanted to try to include the secretary, but they said they could not commit to meeting on Monday evenings. An addict asked what the purpose of the off-month meeting was. WSR explained that the subcommittee previously voted to have this meeting. An addict asked if the WSR Chair thought if the interim meeting was useful. Subcommittee established September 16th at 6:30PM as the next off-month WSR meeting. A motion was made to cancel the off-month WSR meetings and seconded. The

vote was 4 in favor and 4 against. The Chair voted to break the tie. The final vote was 5 in favor and 4 opposed and no abstentions. The motion did not pass.

- A motion was made to read and discuss the concept of the month at the beginning of the meeting. Eliminating the reading of the steps was also added to the motion. 2 opposed. 5 in favor. 1 abstention. Motion passed. Secretary will update the format.
- An addict expressed a desire to have a contact list with subcommittee members' contact info. They also said they would like a document containing the meeting days and times for each areas' H&I subcommittee. Chair will share an old spreadsheet with contact with the secretary to be updated. Secretary will put together these documents and share them with the subcommittee's members.
- An addict asked about the NERNA H&I Chair making a money motion to have NA literature in English and other languages distributed to correctional facilities in the region's respective areas. An addict indicated that distributing literature to facilities was typically delegated to areas. Another addict suggested that maybe this is something that can occur once we are in more correctional facilities.

Patti M and I met to go over her plan for learning day which we will vote on today. I made a money motion at our ASC meeting of \$150 for our annual H&I Learning Day (to be held at the upcoming Spur of the Moment Campout) that was approved.

#### **Panel Coordinator Reports:**

AdCare (Patti M.): 5 commitments, all are filled. Looking for more commitments, masks and vaccination cards are no longer required. No food or drinks should be brought into the commitment. Adcare would like additional commitments if anyone is interested, they'll work with your schedule. Everything stayed the same with exception of two new Panel Leaders Gina W. 2nd Wed of month Hugs not Drugs, Evelyn F. 1st Tuesday of month Notes: some difficulties with space for panel. Sometimes put in a kitchen where people are constantly in and out for snacks and coffee. Explained as renovations happenings can't always find a place for us. They continue to praise H&I as the "hope filled " people. Pick a night any night but all commitments are held 7p-8p. Outside food and drink are

prohibited.

**CHL Detox(Sean B.):** commitments are on hold, will check back this month.

**CHL MYR (Sean B.):** 1st, 3rd Monday, and 2nd Tuesday are all filled beginning September 10th.

CHL TSS (Sean B.): commitments are on hold, will check back this month.

**Naukeag (Marissa R.):** 2 (two) commitments, both filled. The facility does not want virtual commitments.

**RCA (Marci H.):** 12 (twelve) commitments, all but the 1st Sunday and 1st Tuesday are filled. Looking for permanents on those days, so far panel members have been going per diem. The facility does not want virtual commitments.

**Spectrum Detox (Penny D.):** 1 (one) commitment filled. Requesting more commitments if possible.

**Spectrum Faris (Penny D.):** 2 (two) commitments, both filled. Requesting more commitments if possible.

**Spectrum NERC (Penny D.):** 4 (four) commitments, all are filled. Requesting more commitments if possible.

**Sunrise Detox (Frank D.):** 4 (four) commitments with the 1st Sunday filled, the other Sundays open. There have been per diem commitments going in when the facility has asked and we have had the panels to fulfill the request.

Washburn (Andy M.): 4 (four) commitments are currently filled, one at the detox twice a

Wednesdays at CSS and one on the 2nd Sunday. The weekly Wednesday commitment is
currently being covered for the time being with a permanent panel leader being sought.
