- So far we completed one group visit to Athol and should have visited another group by next month.

- this imbalance; one member suggested that changing the format to a speaker meeting could potentially help.
- Several meetings requested addict support: "Get it Together" in Framingham, "Sweet Surrender" in Littleton, "Last Door on the Left" in Littleton, "Never Too Early" in Worcester, and "Message is Hope" in Marlborough. Please see the announcements section for more meeting information.

# Open Forum opened @~8pm

- Several financial matters were discussed
  - Concerns were raised around CMA's regional contributions being significantly lower in comparison to other areas. There was conversation about what factors are causing the area's financial struggles, including but not limited to fellowship-wide post-Covid repercussions, the large number of groups that are not involved with area services, and the current economic climate. There was also conversation about prioritizing area needs separate from NERNA contributions and redirecting focus to self-sustainability efforts which would consequently generate more money to contribute in the future. It was also mentioned that the upcoming area audit will provide more information on why this recurring issue is persisting as well as ways to manage it.
  - There was a discussion surrounding fundraising and ways to increase area income. The issue of the large number of groups that aren't involved in area services was expanded upon, most significantly that these groups do not contribute to area, and mainly the groups that do contribute are the most involved. It was concluded that as the newly revitalized Outreach subcommittee makes contact with these groups, hopefully, there will be an increase in area-level participation and contributions. Another suggestion that was made for fundraising was to increase the number of area events. It was highlighted that the events subcommittee is in need of support, thus limiting the ability to put on more revenue-generating events. The events vice chair requested that should anyone have any ideas for any events please share them.
  - It was revisited that the practice of subcommittee financial reports has fallen out of habit, and for subcommittees to please share any financial information with the area. It was also mentioned that the upcoming area audit will most likely help this practice be more consistent going forward.
- A Google Form has been created by region for groups to fill out and cast their votes on the 12 motions included in the Interim World Service Conference Report (IWR). The deadline for form submission is February 15th, please make sure to review the form with your group before then. The form can be found here, and the full IWR from NA World Services can be found here.
- With the Northeastern States Service Symposium (NESSSNA) quickly approaching, it was suggested that
  this body decide which 4 members it is going to send to attend (2 being funded by region, 2 being
  funded by the area's NESSSNA setaside). It was concluded that this will be revisited at the February ASC
  meeting, as the next regional meeting is shortly after.
  - There will be an orientation held for first-time attendees of NESSSNA on the first day of the event (Friday, April 25th @3:45pm)
- It was mentioned that now that the data collected by the area inventory scan has been presented, this body should select a time to continue with strategic planning based on the given results. It was decided that the best time to conduct a strategic planning session would be at the May ASC meeting, as that is when there will be an overlap in incoming and outgoing trusted servants.
